**Subject: - Appeal of The Principal, Glocal Unani Medical College, Delhi-Yamunotri Marg, State Highway 57, Mirzapur Pole, Dist. Saharanpur-247121, Uttar Pradesh (Inst. Id UNI0427) against the denial of Conditional Permission with 60 seats (instead of 100) in UG (BUMS) course under section 28 of NCISM Act, 2020 for the academic session 2022-23-reg.**

With reference to the appeal filed by Principal, Glocal Unani Medical College, Delhi-Yamunotri Marg, State Highway 57, Mirzapur Pole, Dist. Saharanpur-247121, Uttar Pradesh received by vide college letter no. GUMCH&RC-098/2023 dated 24.02.2023. On the subject mentioned above I am directed to inform you that to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities of Glocal Unani Medical College, Delhi-Yamunotri Marg, State Highway 57, Mirzapur Pole, Dist. Saharanpur-247121, Uttar Pradesh (Inst. Id UNI0427) was visited on 22.08.2022 and 23.08.2022 in hybrid mode by the visitation team of National Commission for Indian System of Medicine to verify for the in order intake capacity of 60 seats (instead of 100) in UG (BUMS) course for the academic session 2022-23 was assessed on the basis of concern regulation and it was observed that the college was not fulfilling the basic eligibility criteria due to various shortcoming.

Further, the college was given an opportunity of virtual hearing on 24.01.2023. In view of the observation of Hearing Committee based on the submission made by the college representatives during hearing, the hearing committee assessed the college in terms of concerned regulation and provisions under the NCISM Act, 2020. It is found that the college was not able to fulfil the basic eligibility criteria for Grant of Conditional Permission. Hence, President MARBISM issued denial of conditional permission for the college and informed the same vide MARBISM Letter Ref. No. 11-48/2022-23/MARB(UNANI) dated 15.02.2023.

Thereafter, an appeal vide letter no. GUMCH&RC-098/2023 dated 24.02.2023 was received in the commission against denial order passed by President MARBISM dated 15.02.2023 which was placed before Chairman, NCISM and Chairman, NCISM constituted a committee.

Accordingly, a letter was sent to the college vide Commission's letter dated 15.03.2023 to appear before the designated hearing committee on dated 17.03.2023 in respect of appeal and to make submission on behalf of college.

The proceedings of appeal was held virtually on 17.03.2023 at 12:00 Noon. On behalf of college, Dr. Rehan Safee, Principal of the college attended the hearing and committee sought clarification from the representatives of the college, which is as under: -

#### Submission of the College

With reference to the subject mentioned above, we wish to submit the following submission in support of our appeal against the Denial of Conditional Permission to the Glocal Unani Medical College, Saharanpur-247121, Uttar Pradesh. The submissions in response to the observations of the hearing committee are as follows:

**1** In the visitations Part 1 Performa we had submitted total number of 32 teachers. Our two teachers left after the submission of part 1 visitation Performa.

a) Dr. Mohd Kaleem, Assistant Professor, Department of Tahaffuzi wa samaji Tib.

b) Dr. Sana Zaki, Assistant Professor, Department of Ilmul Advia. In replacement to these teachers we had advertised on university website and local newspaper in response to that we had appointed Dr. Mohd. Imlaque on 29.08.2022 we had total 30 teachers present on the day of visitation. So we request you to consider the same on the ground as mentioned as per erstwhile CCIM 1970 norms. We had appointed Dr Mohd. Imlaque within 90 days from the date of relieving of previous teachers. So currently we are eligible as we have 90% required staff as per MSR 2016. **2** All the records have been submitted in the previous hearing. In addition the previous documents we want to submit the Birth Certificates certified by the Gram Panchayat Pardhan. Annx:2

**3** All the equipment's and Instrument are available in the Institute. All the stocks registers are verified by the previous CCIM and NCISM visitors and in addition to the previous submission we want to submit copies of bills along with previously verified register by the visitation team. Annx:3(a) & 3(b)

**4.a)** All the leaves of the teaching staff are verified and acknowledged by the competent authority NCISM inspection team directed to submit the same. We have submitted to the visitors. We agree that our 18 staff was on leave and approved by the competent authority. Annx:4

b) In addition to our reply I want to state that we had tie-up with Appsites Infotech which is maintaining our data online. All our OPD's are centrally Computerized. We are maintaining manual registers. Visitation team has cross verified all data on computer during the visitation. All data of OPD has been cross verified during the previous hearing. All data is also present online which can be verified any time.

1.	Teaching staff:- total availability of essential teaching staff is 86.66/0 (Excluding is Excess) a) There is no higher faculty available in the department of Moalajat and 01 lower faculty is short against the minimum requirement of 02. b) There is no lower faculty in the department of Tahaffuzi wa Samaji Tib	The hearing committee observed that total availability of essential teaching staff is 86.66%. The appointment of Assistant Professor Dr. Mohd. Imlaque was done after visitation i.e. on 29.08.2022 as per MSR 2016 section 3 (I) (g) "the position prevailed on the date of visit to assess the fulfilment of requirements as specified in these regulation shall be taken into consideration for grant of conditional permission.". Hence the submission cannot be considered.
2.	Total number of Deliveries conducted in the last calendar (i.e. 1 <sup>st</sup> Jan 2021-31 <sup>st</sup> 2021)	The college informed that total number of 14 deliveries have been conducted in their hospital during the last calendar year the hearing committee asked to submit the case sheet, labour room register etc. The college submitted the documents and have been verified by the hearing committee.
3.	Instruments & Equipment's:- Total availability of mean Instruments and Equipments is 50.42% against the minimum requirement of seventy-five percent	The college informed that they have sufficient number of instruments and equipment's as per MSR. The hearing committee has asked to submit the photo copies of stock register and original bills purchase of instruments/equipments. Copy of stock register has been submitted however, the college has not submitted the copies of original bills due to which the number of equipments could not be verified.
4.	Visitors Observation:- a) Teaching staff present: Only 12 teaching staffs were present and 19 teachers were on unauthorized absence on the day of visitation.	The college informed that most of the staff were visiting their hometown due to long weekend and were not present on day of visitation. Leave application of 18 teachers have been submitted. However, leave application were not verified and signed by NCISM visitation team. Hence submission cannot be considered.

Hence, in view of above, the committee recommends **not to consider the appeal of the Principal, Glocal Unani Medical College, Delhi-Yamunotri Marg, State Highway 57, Mirzapur Pole,**

**Dist. Saharanpur-247121, Uttar Pradesh (Inst. Id UNI0427) against the denial of Conditional Permission with 60 seats (instead of 100) in UG (BUMS) course for the academic session 2022-23.**

Therefore, the recommendation of hearing committee has been placed before Chairman, National Commission for Indian System of Medicine and it has been decided by the Chairperson, NCISM **to dismiss the appeal of by The Principal, Glocal Unani Medical College, Delhi-Yamunotri Marg, State Highway 57, Mirzapur Pole, Dist. Saharanpur-247121, Uttar Pradesh (Inst. Id UNI0427) against the denial of Conditional Permission with 60 seats (instead of 100) in UG (BUMS) course for the academic session 2022-23.**
